





Social Dialogue in the Urban Public Transport Sector in Central and Eastern European Countries







→ What is this project about?

The social dialogue at European level plays an essential role in advancing the European social model, delivering benefits for employers, workers and for the economy and society as a whole. With this initiative, the European social partners for urban public transport, the International Association for Public Transport (UITP) and the European Transport Workers' Federation (ETF), endeavor to promote the European Social Dialogue and discuss its functioning and outcome with the social partners in selected countries of Central and Eastern European social partners to gain knowledge about the functioning and the activities of the social dialogue in those countries.

What happens in this project?

The social partners UITP and ETF invite urban public transport companies and unions to participate in a fact-finding mission and workshop.

In the **fact-finding missions** UITP and ETF wish to discuss industrial relations in urban public transport with the country's companies and unions.

In the workshops, the company and union representatives of the countries involved will help identify suitable practical examples, discuss the results of European social dialogue, and analyse the opportunities and risks of work through social partnership.

→ Result of the project

There will be a report that describes the social models in the countries in UPT and illustrates the possibilities of European social dialogue.

→ What are the benefits for the companies and trade unions?
