#### Introduction

Upon the decisions taken at the Barcelona Congress in 2017, the European Transport Workers' Federation (ETF) embarked on a change process with the view to adapt its structure to serve better the needs of the affiliates and to achieve its renewed political objectives. The changes include the progressive creation of a management team working closely with the General Secretary and which consists of the people coordinating the work of the various sections. Following the changes already implemented in the maritime and aviation department, the structure is being adapted in order to have a political lead which coordinates a team of policy officers in the Land Transport Department. This team would be supported by a dedicated campaigner.

## **Key responsibilities**

- Planning, budgeting, managing and implementing agreed campaigns and projects related to Railways, Road Transport, Urban Public Transport and Logistics
- Doing background research and mapping as required
- Ensuring regular updates are provided to the relevant Section/Committee as appropriate
- Drafting campaign briefings, reports and other documentation as required
- Preparing and promote campaign and project material in cooperation with the Communications Officers as required, including making presentations to internal and external audiences as required
- Developing a network of contacts with key stakeholders that are relevant to the campaigns
- Assisting with the development and drafting of policies or other document as required by the Head of Department
- Providing the Head of Department with potential campaigns based on the sections' and committe's work programme
- Supporting and foster a culture of open communication between staff and affiliates involved with the Land Transport campaigns
- Involving and coordinating affiliates' contributions to the campaigns also in the national level implementation
- Cooperating with the ETF Land Transport team as required
- Liaise with the ITF Land Transport Department, the Campaigns and Communications teams as needed
- Supporting the Head of ETF Land Transport in developing future ETF work on logistics
